NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District (the "Board") will hold a regular public meeting at 19623 Windy Stone Drive, Katy, Texas 77449, Harris County, Texas, said address being a meeting place of the District.

The meeting will be held **Tuesday, March 3, 2026, at 12:00 Noon.**

The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:

1. Public comments;
2. Review and approval of the minutes of the Board meeting of February 3, 2026;
3. Security Report;
4. Authorize consultants to research unclaimed property and consider authorizing District's bookkeeper and tax assessor-collector to prepare Unclaimed Property Report(s) as of March 1, 2026;
5. Bookkeeper's Report, including financial and investment reports; authorize the payment of invoices presented;
6. Tax Assessor-Collector's Report, including status of delinquent taxes; authorize the payment of invoices presented, approval of tax refunds, and transfer of accounts to the uncollectible roll;
7. Review of Delinquent Tax Collection Attorneys' Report from Perdue, Brandon, Fielder, Collins & Mott, L.L.P.; authorize any action necessary and appropriate in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;

 - B. Authorizing the repair and maintenance of District facilities, and the taking of any action in connection therewith, and including authorizing acceptance of Texas Ethics Commission Form 1295 ("TEC Form 1295");

 - E. Approve write-offs of uncollectible accounts;
 - F. Discussion regarding status of manhole repairs; and

 - H. Amended and Restated Emergency Water Supply Agreement between the District and Harris County Municipal Utility District No. 167;

 - C. Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders and authorize acceptance of TEC Form 1295;
 - D. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and the acceptance of facilities for operation and maintenance purposes, including:

 - E. West Harris County Regional Water Authority surface water conversion matters, including:
 - i. Status of design schedule for valve and water line work for the 12-inch Surface Waterline Project; and
 - F. Status of acceptance by Harris County of streets and storm sewers for maintenance;
 - G. Review proposal for replacement of water valves at water plant; and
 - H. Consider approval of Resolution Authorizing Use of Surplus Construction Funds and Interest Earned on Construction Funds in connection with costs associated with completion of the Administration Building;
